

Long Walk Live Parking
Sat 26th June 2026 at Queen Anne Royal Free First School
Terms & Conditions

1. Acceptance of Terms

The operator, Queen Anne Parent And Friends Association (QAPFA), a registered charity No. will be facilitating carparking on behalf of the school with all fees going towards the charitable aims.

By entering or using the school's parking areas, the driver agrees to comply with these Terms & Conditions. The car park is on the grounds of Queen Anne Royal Free First School, Chaucer Close, Windsor, SL4 3EH, it is **not** a public car park. Parking is only allowed in compliance with the conditions below and is strictly limited to the highlighted timeframes.

2. Purpose of the Car Park

The car park is provided **solely** for:

- Prepaid ticket holders parking exclusively for the Long Walk Live event on Saturday 26th June 2026
- Parking is permitted from arrival 12-2pm, until exit at 9-11pm
- No access is provided between 2-9pm, and the carpark will be locked during this period

3. Parking Charges

- The parking fees (£35 per vehicle) must have been paid in full and in advance
- Parking is only permitted for the specific vehicle registered on the booking form
- Parking permits are non-transferable unless explicitly stated and agreed in writing with the organiser in advance
- Failure to pay the required fee, or failure to comply with these Terms & Conditions, may result in additional charges

4. Parking Restrictions

- For booking purposes parking is limited to vehicles that can carry a maximum of 7 individuals only
- Due to access restrictions, there is no parking for minibuses or coaches

Drivers must:

- Only park in bays and marked areas as instructed by site staff. No parking on verges, grassed areas, or unmarked zones is permitted
- Not park in disabled bays, any accessibility requirements must be indicated on the booking form and will be accounted for when parking
- Not block access to emergency routes or pedestrian walkways
- Not double-park or obstruct other vehicles
- Where required, display the valid permit issued at the site entrance

5. Vehicle Owner Liability

The driver is responsible for ensuring compliance with these terms. Where permitted by law, liability may be transferred to the registered keeper if the driver is not identified

6. Prohibited Activities

The following are strictly prohibited:

- Sleeping in vehicles
- EV charging, no facilities are provided
- Vehicle repairs, servicing, or valeting
- Abandoning vehicles
- Commercial trading or unauthorised events
- Dangerous, reckless, or antisocial behaviour

The operator reserves the right to refuse admission to any persons whose behavioural conduct may be considered anti-social.

7. Liability & Disclaimer

Bookings may be cancelled up to 48hrs in advance of the event; no refunds will be issued. The operator reserves the right to cancel the booking at any time, in which case a full refund will be issued.

Parking is entirely at the driver's own risk. The operator accepts no responsibility for:

- Loss, theft, or damage to vehicles or contents
- Injury to persons arising from misuse of the facility
- Mechanical failure or breakdown

8. Removal of Vehicles

The operator reserves the right to:

- Remove vehicles parked in breach of these terms
- Recover associated costs, including towing, storage, and administrative fees

9. Variation of Terms

The operator may amend these Terms & Conditions at any time. Updated terms will be displayed on site and take immediate effect.
